#### **Door County Treatment Court Steering Committee Minutes**

(A Subcommittee of the Criminal Justice Collaborating Council Committee)

Meeting held Thursday, November 17, 2022

Policy for testing is not specific to UAs; as a result, the court may choose the test on a case by case recommendation.

  - ii. Recognition of improvements: adding a case manager to improve reporting and documentation, utilizing affirmations of sobriety, productivity, and legality by Judge D. Weber, maturation of the Court by decrease in termination responses to participant behaviors, and looking for new participant referrals.
  - iii. Holiday Calendar: December 27th to be a lunch for participants in Phases 1-3 and voluntary participation for Phases 4-5; to be held in the Jury Assembly room from 12:30-1:30 PM. January 3rd Court for Participants in Phase 1-2. Staffing to occur at 12:00 PM followed by Court at 12:30 PM.

#### **Community Engagement Activities**

Throughout Treatment Court, participants will be required to participate in community engagement activities. The purpose of these activities is to enable participants to foster positive connections within the County. These connections will provide opportunities for participants to engage in healthy and positive relationships with others in the community and gain knowledge of positive community events to participate in to support their recovery. The following is a suggested list of community engagement activities:

- -Helping at a walk/run support benefit
- -Ringing bells (Salvation Army)
- -Assisting with a food drive/pantry

#### **Community Service Activities**

Throughout Treatment Court, participants may be required to participate in community service activities as a sanction for a violation. The purpose of the activities is to provide the participant with the ability to give back to others and/or the community in a form of making amends. The following is a suggested list of community services activities:

- -Picking up garbage and/or other debris from the side of the road
- -Clearing snow at a designated area
- -Raking leaves at a designated area
- -Moving items at Habitat for Humanity

## **Phase 3: Community Connections Opportunity**

Upon establishing stability within Phases 1 and 2 of Treatment Court, participants within Phase 3 of Treatment Court will be provided with the opportunity to participate in an approved outing, activity, or class to foster connections within their community and develop further skills in support of their recovery. This is a voluntary opportunity by the participant to choose an outing, activity, or class to attend with the Case Manager and/or another Treatment Court Provider; the outing, activity, or class must take place within Door County and be no longer than 3 hours in length. The following is a list of suggested outings, activities, and classes:

- -Completing an art class or project
- -Touring a local art studio
- -Taking a walk at a local State or County Park
- -Going to a local farmer's market
- -Participating in a yoga class
- -Going thrift shopping
- -Attending an orchard and picking fruit
- -Touring a light house
- -Attend a performing arts/theatre show
- -Visiting a Door County Museum or historical landmark
- -Participating in a crocheting or knitting class
- -Participating in a kayak tour
- -Miniature golfing

#### **Drug Testing:**

Door County Treatment Court participation requires random drug and alcohol testing to determine compliance with the rules of the Treatment Court Program. Tests are random and occur a minimum of two times per week throughout the participant's entire program. Participants will select a two-hour daily time slot to conduct their drug test; you will be notified to conduct a test through a text message and/or email two hours ahead of your selected time slot in which you are to report for testing for that day. In keeping with best standards, testing is done at the Door County Jail and observed by trained jail deputies.

In order to conduct drug tests outside of the predetermined and selected time slot, participants must communicate with the Door County Treatment Court Case Manager to obtain prior approval. This approval must be made 48 hours in advance of the day in which the participant would like to complete their potential drug test outside of their time slot. In emergent situations such as medical and/or poor travel conditions due to weather, the participant is still expected to communicate with the Door County Treatment Court Case Manager to provide notice of the emergent situation preventing them from completing their drug test during their scheduled time slot. This contact must be made as soon as possible; if this is outside of regular business hours, it should be made by phone via a phone call or text message. The participant is still expected to complete a drug test within the same day of their notice to conduct the random test.

Positive tests can be challenged for verification and confirmation at the participant's request. You will be required to pay for this additional cost if the test returns as a confirmed positive. Probation agents and treatment providers may also provide drug and/or alcohol screening as necessary per DOC policies and procedures. You may also be required to utilize monitoring devices where necessary. Use of monitoring devices will be based on alcohol and drug use history.

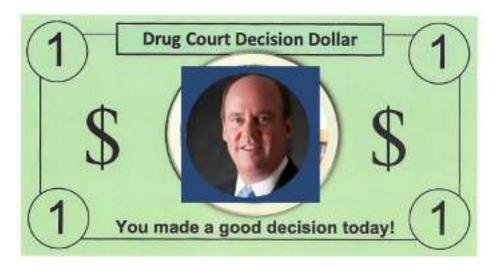
## Incentives and Rewards Ideas

## **Kudos Cards**



- Cards that give recognition to the participants for doing something positive
- Any team member can present a card to a client
- This can be done during the week at appointments, or in court
- Team members present card to the client and take the time to explain the behavior that is being rewarded, why, and how continuing will help them now and in the future.
- Receiving a card allows them to pick a small gift from the "treasure box" that will be an immediate reward in court
  - o (ex: Candy Bars, key chains, bracelets, pens, pencils, etc.)
- They are also eligible to add their name to the raffle box. Raffle will be drawn quarterly
  - o Raffle will be \$50 gift card to a place of their choosing or Door County gift certificate
- Examples of reasons cards can be presented:
  - Attending all appointments, immediate honesty from clients, group participation, showing support of other treatment group members, making good choices, overcoming a hard challenge, asking for help, etc.

#### **Decision Dollars or Weber Bucks**



- Only given by the judge in recognition of participant exemplifying positive decisions and behaviors
- Decision dollars can be used in the Treatment Court Store
- Treatment Court Store would be in the locked cabinets of the Court Services upstairs office.
- Participants can stop after court to make a purchase or they can bank dollars for larger priced items
- Store items would vary in value. Some examples are:
  - Chocolate, candy, granola bars, gift cards, gift cards, flashlights, manicure sets, books, laundry detergent or other household items, mittens, hats, presents for participant's children, etc.

#### **Phases on Boards**

Have two white boards instead of the one. Each participant would have their own magnet that they can decorate. The magnet would continue to hold their fishbowl sticker charts. However, the difference would be that the board would have sections for each Phase. When someone Phases Up, they would move their magnet and sticker paper to the next Phase.

## **Bingo**

- Sample of a board below. The case manager would keep the boards and participants would need to provide proof to case manager to have a space marked off.
- Bingo Cards would advance in ideas as a person progresses through the Phases
- For each "Bingo" achieved the client would receive small gifts or small gift card rewards.

## **Fishbowl Update**

Do we update our fishbowl process? Right now, we have it that the participants need to earn 5 stickers in order to receive a gift card. We could change this process by:

## Making it a Raffle:

Instead of the five stickers, each person puts their name in a bowl. After each court a name is drawn to decide who wins a gift card that day

## Wheel of Sobriety:



- Instead of fishbowl stickers, participants who are eligible that week can spin the wheel to win a prize.
- Prizes vary from praise, written encouragement cards, standing ovations, chance to go first in court, chases to spin again, gift cards, coffee, picking something from the "treasure chest"
