Meeting of the Door County Fair Board

September 17, 2020

Jr. Fair Building, John Miles County Park, Sturgeon Bay, WI

1. The meeting was called to order by President Tom Ash at 6:30 pm. Those in attendance include: Tom Ash, John White, Thad Ash, Sara Mueller, Wayne Spritka, Dan Austead, Steve Jennerjohn, Aaron Ash, JJ Schopf, and Ken Pabich. Tim Ash and Laura Viles were not there.
2. Steve moved to approve the agenda, second by John. Motion carried.
3. Steve moved to approve the minutes from August's meeting, second by Thad. Motion carried.
4. There was nothing to report on from our liaisons.
5. Laura and the Fairest were unable to attend in person, but an email was sent noting that a formal budget request will be coming.
6. 2021 Fair
 - a. Tom talked about contracts. The Bo Deans are set and many others are in the works. Steve will check into any down payments that are still required as Steve is looking to close the 2020 books shortly. Sound Farmers have not responded to any contact, so for 2021 we will be going with a different sound company. They come with an increase in cost, but they have worked with the Bo Deans in the past. We are still waiting on confirmation for fireworks.
 - b. Last year, compensation was discussed for our development coordinators, but no action was taken. More discussion occurred, including adding voting rights, the pros and cons of having more voting members, increased compensation, and finding details in the by-laws. Steve moved to increase compensation for Jeremy and Aaron retrograde 2020 by \$750 and increase to \$2500 for 2021. Roll call votes:
